

**PARENTAL CONSENT, WAIVER OF CLAIMS, AND RELEASE OF LIABILITY
FOR ACTIVITIES CONDUCTED ON THE HARRISON COUNTY FARM**

We, _____, in my individual capacity as well as in my capacity as the parent and/or natural guardian of _____, a Minor, and _____, a Minor, do hereby give our permission and consent to allow the above-named Minor to be present at and participate in any and all activities, including, but not limited to, pond fishing, camping, bonfires, train rides, hay rides, sporting events, recreational games, K-9 demonstrations, and other similar events, at the Harrison County farm located at 14572 County Farm Road, Gulfport, Mississippi 39503 with the _____ group.

In consideration for allowing the above-named Minor to be present at and to participate in such activities on the Harrison County farm, WE HEREBY WAIVE AND RELEASE, indemnify, hold harmless and forever discharge **HARRISON COUNTY, MISSISSIPPI, THE HARRISON COUNTY BOARD OF SUPERVISORS, THE HARRISON COUNTY SHERIFF'S DEPARTMENT, MATT HALEY, BOTH IN HIS INDIVIDUAL AND OFFICIAL CAPACITIES AS SHERIFF OF HARRISON COUNTY, MISSISSIPPI, AND ALL OTHER HARRISON COUNTY SHERIFF'S OFFICERS, DEPUTIES, AND ADMINISTRATORS ASSISTING AND/OR PARTICIPATING WITH SUCH ACTIVITIES AND IN ANY WAY INVOLVED IN OR RESPONSIBLE FOR MAINTAINING, CONTROLLING, OR REPAIRING THE HARRISON COUNTY FARM AND ANY STRUCTURES EXISTING THEREON**, from any and all claims, demands, debts, contracts, expenses, actions, causes of action, lawsuits, litigation, damages and liabilities, of every kind and nature, whether known or unknown, in law or equity, that we ever had or may have, arising from or in any way related to the above-named Minor's presence and participation in activities at the Harrison County farm.

We understand in connection with the above-named Minor's presence at and participation in activities at the Harrison County farm, said Minor may sustain minor or serious injuries, including bodily injury, damage to personal property and/or death. On behalf of myself, the above-named Minor, our heirs, assigns and next of kin, we waive any and all claims for damages, injuries and/or death sustained by us or our property that we may have against the aforementioned released parties.

By this Waiver, we assume any risk, and take full responsibility and waive any claims of personal injury, death or damage to us or our property, including but not limited to, any potential claim involving or associated with the above-named Minor's presence at and participation in activities at the Harrison County farm, whether related to the purpose of this PARENTAL CONSENT, WAIVER, AND RELEASE ("Agreement") or not, both on and off the premises.

This Agreement contains the entire agreement between the parties, and supersedes any prior written or oral agreements between them concerning the subject matter of this Agreement. The provisions of this Agreement may not be waived, altered, amended or repealed, in whole or in part, except upon the prior written consent of all parties.

The invalidity or unenforceability of any provisions of this Agreement shall not affect the validity or enforceability of any other provision of this Agreement, which shall remain in full force and effect. To the extent this Agreement is deemed unconscionable, void and/or contrary to law as it pertains to the above-named Minor, this Agreement shall remain in full force and effect as applied to the Parent/Natural Guardian of the above-named Minor.

We have read, understand and fully agree to the terms of this Agreement. We understand and confirm that by signing this Agreement, we have given up considerable future legal rights. We have signed this Agreement freely, voluntarily, and in consideration of the above-named Minor being allowed to be present upon and participate in activities at the Harrison County farm. Our signatures are proof of our intention to execute a complete and unconditional waiver and release of all liability to the full extent of the law. As the Parent/Natural Guardian of the above-named Minor, I am 21 years of age or older. We are mentally competent to enter into this waiver, and under no duress or undue influence.
